Public Auction Policies:

- All public attendees **MUST** be registered and pay the \$1000 deposit via certified funds. If you are the registered owner of a repossessed vehicle and received a notice of intent letter from the lien holder, you may have free viewing access to the lane in which the vehicle will be offered for sale. A pink vest and security escort will be provided.
- **Each and every public bidder** registrant is required to fully complete this form. In the event of **default (i.e. failure to pay for a purchased vehicle)**, the registrant will pay all costs of collections including reasonable attorney fees. You must present a **valid U.S. driver's license** and be registered as a public bidder for this week in order to bid. Registrants will be issued a pink safety vest that must be worn at all times.
 - Vehicles can be previewed every Monday between the hours of 12:00 PM to 4:00 PM. Registration starts at 8:00 AM Tuesday morning. Not all vehicles are available to public. Please ask if the vehicle of interest is available for public sale before registering.
 - A \$1000 deposit in the form of a blank money order(s) is required before you are allowed to enter the lanes to bid. Upon making the deposit and registering, you will receive a bidder badge (necessary for the auctioneer to take your bid) and a pink safety vest. Your bidder badge will be taken by the block clerk if you are the high bidder. If you want to purchase a second vehicle, you must pay for the first purchase and place a second \$1000 bidding deposit in order to get a second bidder badge so you can bid again. Buyer will be charged a buyer's fee in accordance with Auction policies and prices.
 - In the event of a **default**, you are liable for, the Auction's costs and resale losses, to which the \$1,000 deposit will be applied. You are also responsible for all costs of resale and collections including reasonable attorney fees.
 - Deposit will be refunded same day if no purchase is made. Return to registration window and present bidder badge to receive back your \$1000.00 deposit. All Vehicles **must be** paid in full before **4:00 PM TUESDAY**. Accepted form of payment is money order(s) only. Money order(s) must be payable to Manheim in the amount of \$1000 less than what is owed if you want to have your deposit applied against the purchase price and fees.
- This auction acts solely as an agent to the seller and, in this respect, the registrant is not permitted to hold the auction liable concerning any contract of sale or as a transferor of any vehicle.
- All vehicles are sold "**AS IS, WHERE IS**", without warranty or guarantee, either expressed or implied, as to their merchantability or fitness, their condition of any part thereof, including their suitability for purpose, quality, year of manufacturer, size or model.
- The AUCTION sale is conducted by the auction rules, which are posted and incorporated herein.
- Mileage, model, and other information printed/written on the window of the sale vehicles or in Auction Catalogs is for the convenience of the Buyer and is not to be relied upon as accurate or complete. Buyers should satisfy themselves as to year, mileage, model type, and /or equipment by viewing the actual vehicle prior to bidding. The Auction will not arbitrate vehicles based on incorrect information printed/written on a vehicle or in the catalog.
- Registrants are advised to inspect the vehicle they wish to bid on prior to the sale and will accept it in its present condition at the time of sale.
 - Vehicles may be started; however, they may not be driven or moved out of its assigned spot. After inspection of vehicle, engine must be shut off. Engine revving and tampering with the vehicle is prohibited.
- **All registrants must be 18 years or older to attend. No children or pets are permitted.**
