## VISITOR AGREEMENT

### **Waiver and Indemnification Agreement:**

Manheim ("Manheim" or "Auction") is a private, dealer-only, invitation-only facility. In consideration of allowing Visitor access to the Auction, vehicles and/or its lanes (today or any other day at which Visitor's access to the Auction has not been revoked), the undersigned represents and agrees that: (i) they will obey all laws and regulations, all Auction rules and policies, and the instructions of Auction personnel; (ii) Visitor is not a retail customer or buyer and will not acquire a vehicle sold at this or any Auction sale attended by Visitor; (iii) Visitor will not attempt to buy, sell, or negotiate the purchase of any vehicle sold at this or any Auction sale attended by Visitor with any other person attending such Auction attended by Visitor; (iv) access to the Auction is no guarantee or right of access in the future, and Auction may revoke permission for Visitor to access the Auction at any time, in the Auction's sole discretion; (v) Visitor acknowledges and agrees that Auction is a busy, dangerous place with many vehicles, equipment, and people moving around the premises, and so Visitor agrees it will use extreme care while on Auction premises to avoid injury to themselves and others, as well as any vehicles or other property at the Auction; (vi) Visitor assumes the full risk of, and responsibility for, any and all injury or property damage, including injuries or damage caused by Visitor, when Visitor enters Manheim's private premises; (vii) Visitor hereby releases, waives, and discharges Manheim, its parents, subsidiaries or other affiliates, officers, agents, employees, and representatives (the "Released Parties"), from any and all liability, claims, demands, actions, and causes of action of any kind or nature arising out of or related to any loss, damage, or injury, including death, that Visitor may sustain resulting from Visitor's access to the Auction or in any way connected with Visitor's activities at an Auction, regardless of whether such loss is caused by the negligence of the Auction and regardless of whether such liability arises in tort, contract, strict liability, or otherwise, and covenants not to sue the Auction based on the same; (viii) Visitor further agrees to indemnify and hold harmless the Released Parties from any loss, liability, damage, or costs, including attorneys' fees and court costs that such Released Parties may incur arising out of or related to Visitor's attendance or activities at an Auction, whether caused by the negligence of the Auction or otherwise, including as a result of negligent rescue operations; (ix) Visitor hereby acknowledges and agrees that it is Visitor's express intent that this Visitor Agreement and the included release, waiver of liability, and indemnification (the "Release") bind Visitor's family members, spouse, heirs, assigns, personal representatives, and anyone else entitled to act on Visitor's behalf to the extent they act on Visitor's behalf, and is deemed as a release, waiver, discharge, and covenant not to sue the Released Parties; (x) Visitor further covenants and agrees that this Release shall be construed in accordance with the laws of the State of Georgia and that any mediation, suit, or other proceeding relating to this Release and any activities covered hereby must be filed or entered into only in Georgia and the federal or state courts of Georgia; and (xi) any portion of this Release deemed unlawful or unenforceable is severable and shall be stricken without any effect on the enforceability of the Release as a whole to the full extent authorized by law.

Visitor has read and fully understands this Release, as set forth above, and understands that Visitor has given up substantial rights by signing it. Visitor certifies that it has reached the age of majority and has signed under their own free will.
