

**** Public Notice ** Public Notice ****

- Public Bidders must purchase an annual membership to participate in any Public Sale. Annual Membership fee is \$200.
- Membership Card expires December 31st of the year of issue.
- Public Bidders MUST wear a pink vest for safety, as well as a bidder badge, to properly identify themselves as public bidders. Failure to do so will prohibit entrance to the sale arena. A Driver's License will be held as collateral and given back after the sale when the safety vest is returned.
- A Public premium fee of an additional \$150 will be manually added to the purchase price of vehicle.
- All purchases will have the appropriate buy fee added to the purchase price.
- Those wishing to attend the sale and/or purchase vehicles will need to have: a current Public Buyer Membership, Bidder Badge, Safety Vest and \$500 Money Order or Cashier's Check. The \$500 will be applied to any purchase.
- Guests are not permitted in the sale arena.
- Individuals under the age of 18 are not permitted in the sale arena.
- Public Viewing hours are Tuesday 9am – 5pm. A Driver's license must be left with an auction employee, and a pink safety vest must be always worn while previewing units.
- Wednesday vehicle preview begins at 8am (ONLY with a Paid Membership, Bidder Badge and Safety Vest)
- A valid Membership Card and a valid Driver's License must be presented at every sale.
- Your Membership Card Is NOT REFUNDABLE OR TRANSFERABLE.
- ACCEPTED IF Bids Must Be Paid in Full (including buyer's fee & Public Premium) By 5pm on Thursday. IF bids are binding until 5pm the day of sale.
- Vehicle will be only titled to the individual whose name is listed as 'Purchaser' on paperwork. No exceptions.
- All Vehicles are sold strictly As-Is.
- Full payment must be received by 5pm on Thursday of the week unit was purchased. Failure to pay the remaining balance by Thursday at 5pm will result in revocation of membership.
- *Personal Checks and/or Credit Cards are not accepted as payment!* We only accept CERTIFIED Funds. You MUST have a VALID Government Issued Photo ID when making payment.
- Cashier's Checks Must Be Made Payable to Manheim Cleveland. REMITTER MUST be the individual who purchased the vehicle OR Remitter can be left blank.
- Temporary Tags can be obtained at any Deputy Register's Location.
- Customer agrees to pay a late payment charge of \$50 (fifty dollars) per day on all payments or other charges due at the time Customer tenders a late payment
- If Customer fails to make the required purchase payment by 5pm on the Thursday following the date of sale, Customer agrees to pay Manheim all attorneys' fees, court costs and expenses incurred by Manheim in connection with Manheim's efforts to collect the indebtedness evidenced hereby, and Manheim may exercise from time to time any and all of the rights and remedies available to Manheim at law or in equity.
