

**Manheim Indianapolis Progressive Jackpot 2018 Sweepstakes  
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. THIS PROMOTION IS OPEN ONLY TO LEGAL U.S. RESIDENTS. VOID WHERE PROHIBITED.**

1. **Eligibility.** Subject to the additional restrictions below, the Manheim Indianapolis Progressive Jackpot 2018 Sweepstakes (the "Sweepstakes") is only open to dealerships that: (i) have a valid individual AuctionACCESS membership number as of February 20, 2018; (ii) are not excluded dealerships as described below; and (iii) are located in the fifty (50) United States, the District of Columbia, and Puerto Rico (each, an "Eligible Dealership"). Eligible Dealerships may only enter this Sweepstakes through its representatives who: (i) are eighteen (18) years of age or older at the time of entry; (ii) have a valid individual AuctionACCESS individual identification number (the "100 Million Number") as of February 20, 2018; and (iii) own or are employed by an automobile dealership in good standing with Manheim throughout the Sweepstakes Period that has a valid AuctionACCESS 5 Million dealership number (an "Eligible Buyer"). Employees of Manheim Remarketing, Inc., ("Sponsor"), Cox Automotive, Inc., Cox Enterprises, Inc., and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. 2. **How to Participate.**

The Sweepstakes will be held at Manheim Indianapolis, 3110 S. Post Rd., Indianapolis, IN 46239. The Sweepstakes will begin on February 21, 2018 at 9:00 a.m. Eastern Standard Time ("EST") and end on December 26, 2018, at 3:00 p.m. EST ("Sweepstakes Period"). Sponsor will be the official timekeeper for the Sweepstakes.

All Eligible Buyers in attendance at Manheim Indianapolis on any Wednesday Auction Day between 9:00 a.m. EST and 3:00 p.m. EST during the Sweepstakes Period (the "Entry Period") will be automatically entered into the Sweepstakes. Attendance will be determined based on your completion of the Auction check-in process/Simulcast login process to receive your bidder badge. Each Eligible Buyer receiving a bidder badge will receive one (1) ticket for the day's drawings. One (1) entry per 100 Million Number.

NO PURCHASE NECESSARY TO ENTER.

All entries become property of Sponsor and none will be returned. Any questions shall be determined by Sponsor in its sole discretion, and Sponsor reserves the right to disqualify any entries by persons who submit false or misleading entry information or who Sponsor determines to be tampering with or abusing any aspect of the Sweepstakes.

By participating in the Sweepstakes, participant agrees to all of the terms and conditions of Sponsor's Privacy Policy, available at <http://www2.manheim.com/privacy>. In the event of any discrepancy between the Manheim.com Privacy Policy and these Official Rules, these Official Rules will control.

3. **Winner Selection and Odds.**

At or about 3:00 p.m. EST on each Wednesday Auction Day during the Sweepstakes Period, Sponsor will conduct one (1) random Weekly Drawing from among all eligible entries received during that week's Entry Period. Sponsor will choose one (1) potential prize winner.

POTENTIAL WINNERS MUST BE PRESENT TO WIN.

Odds of winning depend on the number of eligible entries received.

4. **Prize Description.** The potential winner of the Weekly Drawing will receive the chance to win the following prize: one (1) check made payable to the winning Eligible Dealership, in an amount to be determined by the process stated below.

The Weekly Drawing's prize value will begin on the February 21, 2018, Drawing at \$300 US Dollars ("USD"). If, at the end of that Weekly Drawing, there is no eligible winner, the prize value for the drawing will increase by \$100 USD for each subsequent Weekly Drawing. Once a winner is identified for a Weekly Drawing, the prize value will be reset to \$300 USD and will be increased by \$100 USD with each Weekly Drawing until the next eligible winner is identified. The value of the prize depends on the time elapsed since the last award of the prize. If no eligible winner is identified after the final Weekly Drawing, Sponsor, in its sole discretion, may conduct additional drawings from among eligible entries received during the Sweepstakes Period.

Determination of the specific prize value will be made by Sponsor in Sponsor's sole discretion. One (1) Prize will be awarded to one (1) winner for the Weekly Drawings.

The prize(s) will be awarded by a check made payable to the winning Eligible Buyer's Eligible Dealership.

5. **Winner Notification and Acceptance.** The potential prize winner will be notified in person at the close of the drawings. POTENTIAL WINNER OF MUST BE PRESENT TO WIN. Prizes will be fulfilled following Sponsor's confirmation of winner's eligibility and receipt of any required affidavits, releases and tax documents completed by the prize winners. Potential Winner is responsible for claiming and transporting prize.
