

**Manheim Ohio March & April 2018 Bridgecrest Sweepstakes
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. THIS PROMOTION IS OPEN ONLY TO LEGAL U.S. RESIDENTS. VOID WHERE PROHIBITED.

1. **Eligibility.** Subject to the additional restrictions below, the Manheim Ohio March & April 2018 Sweepstakes (the "Sweepstakes") is only open to dealerships that: (i) have a valid individual AuctionACCESS membership number as of March 12, 2018; (ii) are not excluded dealerships as described below; and (iii) are located in the fifty (50) United States, the District of Columbia, and Puerto Rico (each, an "Eligible Dealership"). Eligible Dealerships may only enter this Sweepstakes through its representatives who: (i) are eighteen (18) years of age or older at the time of entry; (ii) have a valid individual AuctionACCESS individual identification number (the "100 Million Number") as of March 12, 2018; and (iii) own or are employed by an automobile dealership in good standing with Manheim throughout the Sweepstakes Period that has a valid AuctionACCESS 5 Million dealership number (a "Eligible Buyer"). Employees of Manheim Remarketing, Inc. ("Sponsor"), Cox Automotive, Inc., Cox Enterprises, Inc., Bridgecrest, and each of their respective affiliated companies, subsidiaries, and advertising and promotional agencies, and the family members of, and any persons domiciled with, any such employees, are not eligible to enter or to win. 2. **How to Participate.**

The Sweepstakes will be held at Manheim Ohio, 3905 Jackson Pike, Grove City, OH 43123. The Sweepstakes will begin on March 13, 2018 at 9:30 a.m. Eastern Standard Time ("EST") and end on April 24, 2018, at 12:00 p.m. EST ("Sweepstakes Period"). Sponsor will be the official timekeeper for the Sweepstakes.

The Sweepstakes will take place between 9:30 a.m. EST and 12:00 p.m. EST on the following sale days: March 13 & 27; April 10 & 24 (each, a "Tuesday Auction Day").

There are two (2) ways to enter the Drawings. Participants may enter the Drawings on in one or both of the following ways:

Purchase Method of Entry: Eligible Buyers may enter the Drawing by (i) purchasing a vehicle(s) from Bridgecrest (each, an "Eligible Purchase"); (ii) on-site at Manheim Ohio or via Simulcast; and (iii) on any Tuesday Auction Day during the Sweepstakes Period. Any purchases that do not meet all criteria listed herein will not be counted as an Eligible Purchase. Subject to verification of eligibility and compliance with these official rules, each Eligible Purchase will count as one (1) eligible entry into the Drawing. You may enter as often as you wish through the purchase method of entry.

You may enter as often as you wish through the free method of entry.

On each Tuesday Auction Day, excluding March 13, 2018, Sponsor will conduct one (1) random drawing from among all eligible entries received on the immediately preceding Tuesday Auction Day, and will announce winners at or about 9:00 a.m. EST. Drawings for the April 24, 2018 Auction Day will take place on May 8, 2018 at or about 9:00 a.m. EST. Sponsor will choose one (1) potential prize winner for each drawing.

Odds of winning depend on the number of eligible entries received.
